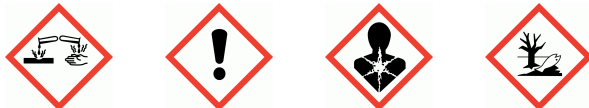

SECTION 5: Firefighting measures

5.1. Extinguishing media
