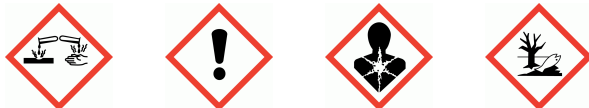

5.1. Extinguishing media
